## Influenza Surveillance Report

### 2014-2015 Influenza Season Week 10 (March 8, 2015 - March 14, 2015)

(All data are preliminary and may change as more reports are received)

#### **SUMMARY**

- 7 cases of Influenza were reported by hospitals during this reporting period
- Zero pediatric-deaths associated with Influenza were recorded during this reporting period
- For the 2014-2015 Influenza Season to-date, 835 positive Influenza cases have been reported
- DC PHL did not test any specimens for week 10, for a total of 146 out of 196 (74.49%) specimens testing positive for influenza
- Week 10 of the current 2014-2015 season has been less severe than the last two seasons, and has not changed from last week

#### INFLUENZA SURVEILLANCE FROM HOSPITALS & AMBULATORY CARE FACILITIES


District of Columbia hospitals and laboratories report detailed information on cases of Influenza on a daily basis. However, in accordance with CDC guidelines, only Influenza-associated deaths in cases <18 years of age and Novel Influenza A infections are reportable.

The table below summarizes weekly and cumulative cases of Influenza for the 2014-2015 Season. Data are also presented by age group and by number of cases reported weekly. During week 10 (March 8, 2015–March 14, 2015), there were 7 new cases of Influenza reported. To date, the District has received 835 positive Influenza cases reported by hospitals.

#### RAPID DIAGNOSTIC TESTING


Rapid Diagnostic Tests are screening tests used to detect the Influenza virus in a short period of time. While initially less accurate than PCR and viral culture, rapid diagnostics are more accurate as the Influenza season progresses. During week 10, 89 out of a total of 113 tests were performed using rapid diagnostic testing in clinical laboratories. Of these, 6 (6.74%) positive Influenza specimens were identified during week 10 using rapid diagnostics.

#### **WEEK 10 COMPARISON WITH PREVIOUS SEASONS**

For week 10, there were 7 cases in the current 2014-2015 season, 13 cases in last year's week 10, 2013-2014 season, and 16 cases during week 10 in the 2012-2013 season.

As there are 53 weeks in the current season compared to other years, the counts for weeks 53 and 1 of this year have been averaged into week 1. Using this method, cumulatively, there are a total of 701 cases of influenza in the district up to week 10 for the current 2014-2015 season, 597 for last year's 2013-2014 season, and 718 for the 2012-2013.



#### **INFLUENZA-LIKE ILLNESS (ILI) SURVEILLANCE**

Sentinel surveillance for ILI consists of three outpatient reporting sites for the District of Columbia. The sentinel surveillance sites report the total number of ILI cases encountered per week and the total number of patients seen at the clinic during that same week. For this system, ILI is defined as the existence of fever (temperature of 100°F [37.8°C] or greater) and a cough and/or a sore throat in the absence of a known cause other than Influenza.

For week 10, sentinel providers reported 92 of 1263 (7.28%) visits that met the criteria for ILI.


# Sentinel Surveillance ILI Activity for Washington, DC

Week of	Activity *
Mar 8 – Mar 14	Sporadic

\*No Activity – overall clinical activity remains low and there are no lab confirmed Influenza cases;

**Sporadic** – isolated lab confirmed Influenza cases reported and ILI activity is not increased;

**Local** – increased ILI activity and recent lab confirmed Influenza cases. As the District of Columbia is not a state, this is the highest level of ILI activity it can report.



#### INFLUENZA TESTING BY THE DISTRICT OF COLUMBIA PUBLIC HEALTH LABORATORY (DC PHL)

The DC PHL subtypes human isolates to monitor the circulating strains of Influenza. The isolates are submitted to the DC PHL by hospitals and commercial laboratories. There were no tests done during week 10, for a total of 146 positive specimens of 196 tested (74.88%), all of which have been influenza A H3.



#### **NATIONAL INFLUENZA ASSESSMENT**

CDC's weekly seasonal surveillance report for week 10 noted that Influenza activity decreased, but continued at elevated levels in the United States. proportion of deaths due to Influenza and pneumonia in the US was above the epidemic threshold. Three Influenza-associated pediatric deaths were reported to the CDC during week 10. of which one was associated with an A(H3) virus, one associated with an un-typed A virus, and one associated with an influenza B virus. For the 2014-2015 season, a total of 107 pediatric deaths associated with Influenza has been reported in the US. During week 10, 15,033 specimens were tested, of which 1,685 (11.2%) were positive. Of the 1,685 respiratory specimens that tested positive during week 10, 551 (32.7%) were Influenza A and 1,134 (67.3%) were Influenza B. Of the Influenza A samples, 3 (0.5%) were 2009 H1N1, 223 (40.5%) were H3, and 325 (59.0%) were not subtyped.
