# Influenza Surveillance Report

Division of Epidemiology - Disease Surveillance and Investigation District of Columbia Department of Health

### 2014-2015 Influenza Season Week 3 (January 18, 2015 – January 24, 2015)

(All data are preliminary and may change as more reports are received)

#### SUMMARY

- 48 cases of Influenza were reported by hospitals during this reporting period.
- 15 additional cases were reported for weeks 1 and 2.
- Zero pediatric-deaths associated with Influenza were recorded during this reporting period.
- For the 2014-2015 Influenza Season to-date, 626 positive Influenza cases have been reported.
- The DC PHL reported no specimens tested this week, but reported additional data was reported for week 2 for a total of 120 out of 158 (76%) specimens testing positive for influenza
- Week 3 of the current 2014-2015 season has been the least severe of the past two years, but activity has increased slightly since last week.

#### **INFLUENZA SURVEILLANCE FROM HOSPITALS & AMBULATORY CARE FACILITIES**

District of Columbia hospitals and laboratories report detailed information on cases of Influenza on a daily basis. However, in accordance with CDC guidelines, only Influenza-associated deaths in cases <18 years of age and Novel Influenza A infections are reportable.

The table below summarizes weekly and cumulative cases of Influenza for the 2014-2015 Season. Data are also presented by age group and by number of cases reported weekly. During week 3 (January 18, 2015–January 24, 2015), there were 48 new cases of Influenza reported. 15 additional cases for weeks 1 and 2 were reported as well. To date, the District has received 626 positive Influenza cases reported by hospitals.

Positive Influenza Tests by Week

#### **RAPID DIAGNOSTIC TESTING**

Rapid Diagnostic Tests are screening tests used to detect the Influenza virus in a short period of time. While initially less accurate than PCR and viral culture, rapid diagnostics are more accurate as the Influenza season progresses. During week 3, 293 out of a total of 343 tests were performed using rapid diagnostic testing in clinical laboratories. Of these, 45 (15.36%) positive Influenza specimens were identified during week 3 using rapid diagnostics.

#### WEEK 53 COMPARISON WITH PREVIOUS SEASONS

For week 3, there were 48 cases in the current 2014-2015 season, 94 cases in last year's week 3, 2013-2014 season, and 67 cases during week 3 in the 2012-2013 season.

As there are 53 weeks in the current season compared to other years, the counts for weeks 53 and 1 of this year have been averaged into week 1. Cumulatively, there are a total of 492 cases of influenza in the district up to week 3 for the current 2014-2015 season, 337 for last year's 2013-2014 season, and 535 for the 2012-2013.



#### INFLUENZA-LIKE ILLNESS (ILI) SURVEILLANCE

Sentinel surveillance for ILI consists of three outpatient reporting sites for the District of Columbia. The sentinel surveillance sites report the total number of ILI cases encountered per week and the total number of patients seen at the clinic during that same week. For this system, ILI is defined as the existence of fever (temperature of 100°F [37.8°C] or greater) and a cough and/or a sore throat in the absence of a known cause other than Influenza.

For week 3, sentinel providers reported 86 of 1294 (6.65%) visits that met the criteria for ILI.

\*No Activity – overall clinical activity remains low and there are no lab confirmed Influenza cases;

**Sporadic** – isolated lab confirmed Influenza cases reported and ILI activity is not increased:

**Local** – increased ILI activity and recent lab confirmed Influenza cases. As the District of Columbia is not a state, this is the highest level of ILI activity it can report.



#### INFLUENZA TESTING BY THE DISTRICT OF COLUMBIA PUBLIC HEALTH LABORATORY (DC PHL)

The DC PHL subtypes human isolates to monitor the circulating strains of Influenza. The isolates are submitted to the DC PHL by hospitals and commercial laboratories. No specimens were reported by the PHL for week 3, but additional data was reported for week 2, for a total of 120 positive specimens of 158 tested (74.83%), all of which have been influenza A H3.

#### NATIONAL INFLUENZA ASSESSMENT

The CDC's weekly seasonal Influenza surveillance report for week 3 noted that Influenza activity continued at elevated levels in the United States. The proportion of deaths due to Influenza and pneumonia in the US was above the epidemic threshold. Five Influenzaassociated pediatric deaths were reported to the CDC during week 3, of which four were associated with an A(H3) virus, and one was associated with an un-typed A virus. For the 2014-2015 season, a total of 61 pediatric deaths associated with Influenza has been reported in the US. During week 3, 23,339 specimens were tested, of which 4,651 (19.9 %) were positive. Of the 4,651 respiratory specimens that tested positive during week 3, 4,343 (93.4%) were Influenza A and 308 (6.6%) were Influenza B. Of the Influenza A samples, 2 (0.05%) were 2009 H1N1, 1,698 (39.1%) were H3, and 2,643 (60.9%) were not subtyped.
