

# Influenza Surveillance Report

## SUMMARY

- 73 cases of Influenza were reported by hospitals during this reporting period.
- Zero pediatric-deaths associated with Influenza were recorded during this reporting period.
- For the 2013-2014 Influenza season to-date, 264 positive Influenza cases have been reported.

## INFLUENZA SURVEILLANCE FROM HOSPITALS & AMBULATORY CARE FACILITIES

District of Columbia hospitals and laboratories report detailed information on cases of Influenza on a daily basis. However, in accordance with CDC guidelines, only Influenza-associated deaths in cases <18 years of age and Novel Influenza A infections are reportable. Please note that data from hospitals include all cases received by participating hospitals, regardless of residency.


The table below summarizes weekly and cumulative cases of Influenza for the 2013-2014 Season. Data are also presented by age group and by number of cases reported weekly. During week 3 (January 12, 2014– January 18, 2014), there were 73 new cases of Influenza reported. To date, the District has received 264 positive cases reported by hospitals.



**RAPID DIAGNOSTIC TESTING**

Rapid Diagnostic Tests are screening tests used to detect the Influenza virus in a short period of time. While initially less accurate than PCR and viral culture, rapid diagnostics are more accurate as the Influenza season progresses. During week 3, 270 out of a total of 389 tests were performed using rapid diagnostic testing in clinical laboratories. Of these, 63 of the 270 (23.33%) rapid tests tested positive for influenza during week 3. Four of the ten remaining positive tests were done using serology, with the remaining six with RT-PCR.

**INFLUENZA-LIKE ILLNESS (ILI) SURVEILLANCE**

Sentinel surveillance for ILI consists of three outpatient reporting sites for the District of Columbia. The sentinel surveillance sites report the total number of ILI cases encountered per week and the total number of patients seen at the clinic during that same week. For this system, ILI is defined as the existence of fever (temperature of 100°F [37.8°C] or greater) and a cough and/or a sore throat in the absence of a known cause other than Influenza.

For week 3, sentinel providers reported 136 of 1099 (12.38%) visits met the criteria for ILI. Also in week 3, additional ILI cases were reported for week 2, for a total of 172 out of 1049 (16.40%) visits meeting the criteria for ILI.



**\*No Activity** – overall clinical activity remains low and there are no lab confirmed Influenza cases;

**Sporadic** – isolated lab confirmed Influenza cases reported and ILI activity is not increased;

**Local** – increased ILI activity and recent lab confirmed Influenza cases. As the District of Columbia is not a state, this is the highest level of ILI activity it can report.

## INFLUENZA TESTING BY THE DISTRICT OF COLUMBIA PUBLIC HEALTH LABORATORY (DC PHL)

The DC PHL subtypes human isolates to monitor the circulating strains of Influenza. The isolates are submitted to the DC PHL by hospitals and commercial laboratories. In week 3, 15 of 15 specimens sent to the PHL have tested positive for Influenza. To date, 98 specimens have been tested, of which there have been 53 positive specimens. All but five of the isolates were subtyped as Influenza A/H1 2009 H1N1, with the remaining five being subtyped as Influenza A H3.



## NATIONAL INFLUENZA ASSESSMENT

The CDC's weekly seasonal Influenza surveillance report for week 3 noted that Influenza activity remained high in the United States. The proportion of deaths due to Influenza and pneumonia in the US was above the epidemic threshold. Eight Influenza-associated pediatric deaths were reported to the CDC during week 3, with five associated with a 2009 H1N1 virus, and the other three un-typed. For the 2013-2014 season, a total of 28 pediatric deaths associated with Influenza have been reported in the US. During week 3, 12,108 specimens were tested, of which 2,793 (23.1%) were positive. Of the 2,793 respiratory specimens that tested positive during week 3, 2,707 (96.9%) were Influenza A, and 86 (3.1%) were Influenza B. Of the Influenza A samples, 1,727 (63.8%) were 2009 H1N1, 58 (2.1%) were H3, and 922 (34.1%) were not subtyped.
