OS-1209-01	<u>MINUTES</u> <u>Board Action:</u> The Board approved the September 9, 2014 Open Session meeting minutes.	
OS-1209-02	<u>EXECUTIVE DIRECTOR'S REPORT</u> There was no report.	
OS-1209-03	<u>BOARD ATTORNEY'S REPORT</u> <u>Board Action:</u> The Board Attorney reported on a case before the U.S. Supreme Court involving the North Carolina Board of Dentistry that may have broad implications for how regulatory boards operate.	
OS-1209-04	<u>BOARD CHAIRPERSON'S REPORT</u> <u>Board Action:</u> The Board Chair discussed the scope of practice for fitness professionals and that this Board would like the practitioners to know the importance of licensure, especially if providing dietetics/nutrition counseling.	
OS-1209-05	<u>SCOPE OF PRACTICE DISCUSSION</u> <u>Board Action:</u> As the Board plans to consider law and regulation updates to clarify the definitions and scope of practice for each profession (Dietitians and Nutritionists), they engage in conversation with members of the public. During the conversation the Board discussed the possibility of multi-level licensure for nutritionists and dietitians as well as other licensure schemes.
