

ORDER

On consideration of appellant's motion in appeal no. 13-CV-1059 to consolidate with previously consolidated appeals nos. 13-CV-348, 13-CV-358 & 13-CV-582, and it appearing that the complete record on appeal has been filed in appeal no. 13-CV-1059, and appellant's motion in appeal no. 13-CV-582 for an extension of time to file the brief and the appendix, to which no opposition has been filed, it is

ORDERED that appellant's motion in appeal no. 13-CV-1059 to consolidate is granted and appeal no. 13-CV-1059 is consolidated with previously consolidated appeals nos. 13-CV-348, 13-CV-358, & 13-CV-582. It is

FURTHER ORDERED that that appellant's motion in appeal no. 13-CV-582 for an extension of time is granted and appellant's brief and the appendix shall be filed on or before November 18, 2013. No further extension of extensions of time will be granted absent a showing of good cause. Failure to comply with this order shall result in the dismissal of appeal no. 13-CV-582 without further notice. *See* D.C. App. R. 13. It is

FURTHER ORDERED that appellant's brief addressing the issues raised in appeal no. 13-CV-1059, shall be filed within 40 days from the date of this order, and appellees' consolidated briefs shall be filed within 30 days thereafter.
