ORDER APPROVING PAYMENT FOR PROVIDER APPEALS

On July 3, 2014, D.C. Chartered Health Plan, Inc., acting through its Rehabilitator, Special Deputy to the Rehabilitator and their attorneys (“Chartered”), filed a *Petition for Approval of Payment for Fourth Set of Provider Claim Appeals*.
