ISSUE: Vulnerable Population and Employer Protection Amendment Act of 2017. This bill seeks to amend HORA to authorize a health occupations board to take disciplinary actions against a health professional who engages in the financial exploitation of a patient, client, or employer.

MATTERS FOR BOARD CONSIDERATION Regulation Committee

RN Regulations [Table for discussion at future BON meeting] Current proposed language

5407.5 Applicants who pass NCLEX five (5)/three (3) years or more after the date the applicant became eligible to apply to sit for examination must submit proof of having completed a RN refresher course, prior to licensure.

At its July 2017 meeting the Board asked staff to research how other BONs address the issue regarding remediation. The results are below:
