Week 19 (May 4, 2014 – May 10, 2014)

(All data are preliminary and may change as more reports are received)

SUMMARY

- 9 cases of Influenza were reported by hospitals during this reporting period.
- Zero pediatric-deaths associated with Influenza were recorded during this reporting period.
- For the 2013-2014 Influenza season to-date, 696 positive Influenza cases have been reported.

INFLUENZA SURVEILLANCE FROM HOSPITALS & AMBULATORY CARE FACILITIES

District of Columbia hospitals and laboratories report detailed information on cases of Influenza on a daily basis. However, in accordance with CDC guidelines, only Influenza-associated deaths in cases <18 years of age and Novel Influenza A infections are reportable. Please note that data from hospitals include all cases received by participating hospitals, regardless of residency.


The table below summarizes weekly and cumulative cases of Influenza for the 2013-2014 Season. Data are also presented by age group and by number of cases reported weekly. During week 19 (May 4, 2014– May 10, 2014), there were 9 new cases of Influenza reported. To date, the District has received 696 positive cases reported by hospitals.



RAPID DIAGNOSTIC TESTING

Rapid Diagnostic Tests are screening tests used to detect the Influenza virus in a short period of time. While initially less accurate than PCR and viral culture, rapid diagnostics are more accurate as the Influenza season progresses. During week 19, 68 out of a total of 96 tests were performed using rapid diagnostic testing in clinical laboratories. Of these, 8 of the 68 (11.75%) rapid tests tested positive for influenza during week 19. The remaining two positive tests were performed using serology.

INFLUENZA-LIKE ILLNESS (ILI) SURVEILLANCE

Sentinel surveillance for ILI consists of three outpatient reporting sites for the District of Columbia. The sentinel surveillance sites report the total number of ILI cases encountered per week and the total number of patients seen at the clinic during that same week. For this system, ILI is defined as the existence of fever (temperature of 100°F [37.8°C] or greater) and a cough and/or a sore throat in the absence of a known cause other than Influenza.


For week 19, sentinel providers did not report data for visits meeting the criteria for ILI, but for weeks 16, 17, and 18, additional cases that met the criteria for ILI were reported, with 98, 123, and 37 cases respectively.

Week of	Activity *
May 4 – May 10	<i>Sporadic</i>

- *No Activity** – overall clinical activity remains low and there are no lab confirmed Influenza cases;
- Sporadic** – isolated lab confirmed Influenza cases reported and ILI activity is not increased;
- Local** – increased ILI activity and recent lab confirmed Influenza cases. As the District of Columbia is not a state, this is the highest level of ILI activity it can report.

INFLUENZA TESTING BY THE DISTRICT OF COLUMBIA PUBLIC HEALTH LABORATORY (DC PHL)

The DC PHL subtypes human isolates to monitor the circulating strains of Influenza. The isolates are submitted to the DC PHL by hospitals and commercial laboratories. During week 19 four specimens were tested with none positive. To date, 240 specimens have been tested, of which there have been 147 positive specimens. All but 20 of the isolates were subtyped as Influenza A/H1 2009 H1N1, with 13 being subtyped as Influenza A H3 and 7 being subtyped as Influenza B.



NATIONAL INFLUENZA ASSESSMENT

The CDC's weekly seasonal Influenza surveillance report for week 19 noted that Influenza activity continued to decrease. The proportion of deaths due to Influenza and pneumonia in the US was below the epidemic threshold. Three Influenza-associated pediatric deaths were reported to the CDC during week 19. One was associated with a H3 A virus, one with an un-typed A virus, and one with an influenza B virus. For the 2013-2014 season, a total of 94 pediatric deaths associated with Influenza have been reported in the US. During week 19, 3,381 specimens were tested, of which 342 (10.1%) were positive. Of the 342 respiratory specimens that tested positive during week 19, 142 (41.5%) were Influenza A and 200 (58.5%) were Influenza B. Of the Influenza A samples, none were 2009 H1N1, 59 (41.5%) were H3, and 83 (58.5%) were not subtyped.
