2016-2017 Influenza Season Week 43 (October 23, 2016 – October 29, 2016)

(All data are preliminary and may change as more reports are received)

SUMMARY

- 5 cases of Influenza were reported by hospitals during this reporting period
- 1 additional case was reported for week 42
- Zero pediatric deaths were reported during this period
- For the 2016-2017 Influenza Season to-date, 17 positive Influenza cases have been reported
- DC PHL did not report any specimens tested for week 43
- Flu activity has been steady, and remains low in the District

INFLUENZA SURVEILLANCE FROM HOSPITALS & AMBULATORY CARE FACILITIES



District of Columbia hospitals and laboratories report detailed information on cases of Influenza on a daily basis. However, in accordance with CDC guidelines, only Influenza-associated deaths in cases <18 years of age and Novel Influenza A infections are reportable. We also request that Influenza hospitalizations be reported if possible.

The table below summarizes weekly and cumulative cases of Influenza for the 2016-2017 Season. Data are also presented by age group and by number of cases reported weekly. During week 43 (October 23, 2016–October 29, 2016), there were 5 new cases of Influenza reported. One additional case was reported for week 42. To date, the District has received 17 positive Influenza cases reported by hospitals.

RAPID DIAGNOSTIC TESTING

Rapid Diagnostic Tests are screening tests used to detect the Influenza virus in a short period of time. While initially less accurate than PCR and viral culture, rapid diagnostics are more accurate as the Influenza season progresses. During week 43, 78 out of a total of 197 tests were performed using rapid diagnostic testing in clinical laboratories. Of these, 1 (1.28%) positive Influenza specimens were identified during week 43 using rapid diagnostics.



WEEK 43 COMPARISON WITH PREVIOUS SEASONS

For week 43, there were 5 cases in the current 2016-2017 season, 1 cases in last year's 2015-2016 season, 0 cases in the 2014-2015 season, 15 in the 2013-2014 season, and 0 in the 2012-2013 season.

Cumulatively, there are a total of 17 cases in the district up to week 43 for the current season, 10 during the 2015-2016 season, 4 in the 2014-2015 season, 33 in the 2013-2014 season, and 5 in the 2012-2013 season.

INFLUENZA-LIKE ILLNESS (ILI) SURVEILLANCE

Sentinel surveillance for ILI consists of three outpatient reporting sites for the District of Columbia. The sentinel surveillance sites report the total number of ILI cases encountered per week and the total number of patients seen at the clinic during that same week. For this system, ILI is defined as the existence of fever (temperature of 100°F [37.8°C] or greater) and a cough and/or a sore throat in the absence of a known cause other than Influenza.

For week 43, sentinel providers reported 161 of 2891 (5.57%) visits that met the criteria for ILI. 148 additional visits were reported for week 42.



***No Activity** – overall clinical activity remains low and there are no lab confirmed Influenza cases;

Sporadic – isolated lab confirmed Influenza cases reported and ILI activity is not increased;

Local – increased ILI activity and recent lab confirmed Influenza cases. As the District of Columbia is not a state, this is the highest level of ILI activity it can report.

INFLUENZA TESTING BY THE DISTRICT OF COLUMBIA PUBLIC HEALTH LABORATORY (DC PHL)

The DC PHL subtypes human isolates to monitor the circulating strains of Influenza. The isolates are submitted to the DC PHL by hospitals and commercial laboratories. DC PHL did not report any specimens tested for week 43.



NATIONAL INFLUENZA ASSESSMENT

The CDC's weekly seasonal Influenza surveillance report for week 43 noted that influenza activity was low in the United States. The proportion of deaths due to Influenza and pneumonia in the US was below the epidemic threshold. Two pediatric deaths were reported to the CDC during week 43, but for the previous season. For the 2016-2017 season, a total of 0 pediatric deaths associated with Influenza have been reported in the US. During week 43, 493 specimens were tested by public health laboratories, of which 33 were positive. Of the 33 respiratory specimens that tested positive during week 43, 28 (84.8%) were Influenza A and 5 (15.2%) were Influenza B. Of the Influenza A samples, 6 (21.4%) were 2009 H1N1, 21 (75.0%) were H3, and 1 (3.6%) was untyped.
