	<p>Department of Health’s CHA regulation - Section 7-852 of the D.C. Code, which identifies which professionals can perform newborn hearing screenings.</p> <p>After much discussion, the Board decided that because the instrument used in the newborn screening actually performs the analysis, the technicians receive appropriate training, and the individuals are identified as professionals in the CHA rules, that the technicians are not practicing as an audiologist or speech-language assistant and would not require a license.</p> <p>The Board did request that documentation indicating the training the technicians receive be sent for their information.</p>	
OS-0320-03	<p><u>PROPOSED REGULATIONS</u></p> <p><u>Board Action:</u> The Board reviewed and approved the final rulemaking regulations for Speech-Language Pathologists, Audiologists, Clinical Fellows, SLP Assistants, and AUD Assistants.</p>
