	<p><b><u>Executive Director’s Report:</u></b></p> <p><b><u>Board Action:</u></b> The Executive Director reported that the D.C. Office of Open Government found that the Board of Medicine violated the Open Meetings Act. As a result, the Sr. Deputy Director wants all boards and staff to take a refresher course on compliance with the Open Meetings Act. She reported that open meetings requirements must be adhered to by all of the Department of Health’s licensing boards moving forward.</p>	
	<p><b><u>Chairperson’s Report:</u></b></p> <p><b><u>Board Action:</u></b> The Board Chair opened with a cheerful welcome to the Board’s new members–Kristin Spivey, SLP, and Kari Comer, SLP. OS-o6o6-01	<p><b>MINUTES</b></p> <p><u>Board Action:</u> The Open Session Minutes of the March 21, 21o6 meeting were approved with the correction that the date "December 21, 2015" be removed.</p>	
OS-o6o6-02	<p><b><u>CLINICAL FELLOWS, AUDIOLOGY ASSISTANTS, AND SLP ASSISTANTS UPDATE</u></b></p> <p><u>Board Actions:</u></p> <p>The Board approved the SLP and SLP Assistant draft regulations.</p> <p>The Board amended the SLP regulations to allow SLPs to supervise Audiology Assistants.</p> <p>The Board approved the Audiology Assistant regulations.</p> <p>The Board also decided that licensees who have had inactive D.C. licenses for more than five (5) years and have not practiced in any other jurisdiction must show professional competency before having their D.C. licenses reactivated. Thus, the Board found that this competency would be best achieved by requiring supervision by actively practicing licensees. This change will be the same for all professions under this Board's jurisdiction.</p>
