The Graduate Professional Counselor license is issued to qualified applicants who meet the educational requirements. The license is issued once for a five year period and must be renewed every two years. Remember in order to work in the District of Columbia, you **MUST** have a license. That **INCLUDES** working towards your required supervision hours.

Please use the provided checklist to assist in the application process. It is **IMPORTANT** to send all of the required documents listed below based on the method by which you are applying for licensure.

<u>Graduate Professional Counselor License by</u> Examination

- Two (2) recent passport photos (2" X 2")
- Copy of Identification Document (Driver's License, Passport, etc....)
- Social Security Number or a Sworn Affidavit
- Name Change Documents (if applicable)
- Passing Scores from National Exam (if applicable) (See regulations for acceptable exams)
- Official Sealed Transcript(s) Master's degree or higher in counseling or related field with a minimum of 48 hours (see regulations for complete list of acceptable programs)
- Completed Internship/Practicum Form (If your program was not CACREP accredited at graduation)
- Course Completion Form

- □ \$230 in form of Check, Money Order, or Certified Check payable to the D.C. Treasurer

*Appropriate Supervisors: ONLY a Professional Counselor, Psychologist, Psychiatrist, or Independent Clinical Social Worker who was licensed in a jurisdiction of the United States during the supervised period.
